

## Night Golf 2 Person Ambrose – Thu 11<sup>th</sup> Apr 24



### CONDITIONS OF PLAY

#### **The Event:**

The Night Golf 2 Person Ambrose will be a 9-hole shotgun start event on Thursday 11<sup>th</sup> April 2024. The complete course will be used with players being allocated a starting hole and completing their round after 9 consecutive holes. Glow golf balls will be provided for each team and the tees, flag sticks and route between green and tee (where required) will be marked with glow sticks.

A BBQ will be held commencing at 5:30pm, and all players must report to the Club Starter by 6:00pm on the day of the event. An event briefing will be held at 6:30pm.

#### **Eligibility:**

The event is open to all male and female golfers. **All players must sign the waiver agreement prior to playing.**

#### **Handicaps:**

Golf Australia handicaps are not required for a player to participate in this event.

#### **Safety:**

Safety is paramount for this event as it will be played at night on a golf course with trees, hazards and little ambient light. As such **no** carts or ride on buggies/scooters will be allowed for the event.

Teams will be paired up, where possible, to ensure that each group has at least one FGC player in it for guidance around the course.

All players are required to complete a participant waiver acknowledging that they are aware of the risks, are participating voluntarily and are responsible for their own safety. A copy of this waiver agreement is attached to these conditions of play.

#### **Entry:**

Entries can be made directly with the club staff and will close once the field is full. Full entry fees can be paid on the day - \$30.00 for FGC members and \$40 for visitors. The club will make every effort to pair up individual players to make teams.

#### **Event Completion Timeframe:**

The event will conclude when teams have played their allocated 9 holes or 2 hours have elapsed. All teams are to have returned to the clubhouse by 9:15 pm to be eligible for the prize pool draw.

#### **Rules:**

The Event will be played on a mix of the green and yellow courses. Teams are only to play 9 sequential holes (max) including their allocated starting hole (note completion time limit above). The maximum team score on any one hole is 6 shots – pick up and move on after these 6 shots. Sharing of clubs is allowed for each team if required. If a team loses their balls they can continue by playing their one remaining glow ball (alternate shots) or choose to end their round.

Order of play: Play in any order, regardless of whose ball is chosen or who holed out on last hole.

Chosen ball:

- **On the green:** Place your second players ball within 1 card length of the chosen ball. To assist with speed of play, first player may putt out if close to hole.
- **Everywhere else on the course:** Place your second players ball within one club length of the chosen ball (including bunkers and penalty areas).

#### **COVID:**

The club reserves the right to adjust the event to comply with any COVID restrictions on business in place at the time.

## Fairbairn Golf Club Night Golf - Participant Waiver

**By signing to this waiver agreement, the Participant and the Fairbairn Golf Club agree to the following terms:**

1. The participant agrees that their participation in the Night Golf event on Thursday 11<sup>th</sup> April 2024 is voluntary. Additionally, the participant agrees to assume any risk that is associated with participating in the event and releases Fairbairn Golf Club from all claims of damage and loss that may arise as a result of participation. The release is without limitation and includes any personal injury fees, attorney's fees and any other losses that might occur to the participant.
2. The participant agrees to hold Fairbairn Golf Club harmless against all claims of damage and loss including damage to Fairbairn Golf Club property caused by the participant.
3. The participant acknowledges that the night balls used are harder than normal and that woods could be damaged - only irons should be used .
4. The participant hereby warrants that they are physically fit and able to participate in the Night Golf event without any undue risk.
5. Fairbairn Golf Club maintains that the right to refuse participation in the Night Golf event if it foresees that participation would risk damage to any party.
6. Fairbairn Golf Club does not provide insurance cover for the participants in the event.
7. This waiver agreement is governed by the laws of the ACT. Any legal claims or lawsuits related to the precipitants in the Night Golf event shall take place in courts located in Canberra, ACT.
8. The participant agrees that this waiver agreement shall remain in full force and take effect without change and that participation in the Night Golf event is pursuant to the terms of the agreement.
9. By signing this document, the participant agrees they have read and fully understood this waiver agreement.
